### WHY THIS INFORMATION?

Pursuant to Regulation (EU) 2016/679 (hereinafter “Regulation or “GDPR”), this page describes the methods of processing the personal data of users who consult the website of Valoridicarta S.p.A. (hereinafter “Valoridicarta”), which is accessible electronically at the following address:

The privacy policy is provided only for the Valoridicarta website and does not concern other sites, pages or online services that can be reached via hypertext links that may be published on the site but referring to resources outside the domain of Valoridicarta.

By using the site listed above, data may be processed relating to identified or identifiable natural persons.

### DATA CONTROLLER

The Data Controller is **Valoridicarta S.p.A.**, with registered address in Rome (Italy), Via Salaria 691.

### LEGAL BASIS OF PROCESSING

The personal data indicated on this page are processed by Valoridicarta in the performance of its tasks of public interest or in any case connected to the exercise of its institutional tasks (Art. 6(1)(e) GDPR). Valoridicarta operates in compliance with the rules established for publicly controlled companies and is subject to the joint management and coordination of the Istituto Poligrafico e Zecca dello Stato S.p.A. and Banca d'Italia, according to the model of in-house providing.

### TYPES OF DATA PROCESSED AND PURPOSES OF PROCESSING

#### Navigation data

The computer systems and software procedures used for this website acquire, during their normal operations, some personal data which is implicitly provided when using internet communication protocols.

This category of data includes IP addresses or domain names of the computers or terminals employed by users, addresses in the URI/URL (Uniform Resource Identifier/Locator) of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file in reply, the numerical code indicating the status of the response given by the server (done, error, etc.) and other parameters related to the operating system and the computer environment of the user.

These data, necessary for the use of web services, are also processed for the purpose of:

- obtaining statistical information on the use of services (most visited pages, number of visitors by time or day, geographical areas of origin, etc.);
- monitoring the proper functioning of the site.

This data is deleted from the server 7 days after processing.

#### Data provided by the user

The optional, explicit and voluntary sending of messages to the contact addresses of Valoridicarta implies the acquisition of the sender's contact details, which are necessary to reply, as well as all personal data included in the communication.

Personal web contact details shall be held for more than 180 days, unless requested by judicial authorities or law enforcement agencies.

## **Cookies**

Technical session cookies (non-persistent) are used, strictly limited to that which is necessary for the secure and efficient navigation of the site [www.valoridicarta.it](http://www.valoridicarta.it).

### **Cookies are not used for user profiling.**

The only processing carried out is for the purpose of generating statistics using anonymised data in order to gather information on the use and navigation of the site [www.valoridicarta.it](http://www.valoridicarta.it) through the use of third-party analytics cookies collected and processed by the centralised platform Web Analytics Italia (WAI). ## **DATA RECIPIENTS**

- by designated system administrators pursuant to the provision of the Italian Data Protection Authority of 27 November 2008 and subsequent additions and amendments.

## **RIGHTS OF THE DATA SUBJECT**

Data subjects have the right to obtain, in the cases foreseen, access to their personal data and their correction or cancellation or the limitation of the processing that concerns them or to object to the processing (Articles 15 et seq. of the GDPR).
